Re: <u>HB 2526 – 2023 Regular Legislative Session</u>

West Virginia Property Tax Adjustment Act

Dear Honorable Delegates and Honorable Senators:

The Kanawha County Commission would first like to commend you and Governor Jim Justice for passing this critical and historic legislation. If it were not for everyone's collective leadership and vision, the taxpayers would not have the opportunity to reap these much-needed tax cuts. So, on behalf of all Kanawha Countians, we say thank you.

As we all know, the 2023 Tax Year is upon us, as we have all received our real property and personal property tax tickets that were sent out this month. As a result, we have fielded numerous inquiries regarding the application of HB 2526. Currently, only the second half payment made in 2024 is eligible for a tax credit on the 2024 income tax return filed in 2025, contingent upon the

first half being timely paid. We have advised our shared constituents of this fact, but despite our instructions, we still find them confused as they continue to send in payments for the entire tax year, making them ineligible for the income tax credit. We believe this outcome is different from the desired result you intended when drafting HB 2526.

Simply put, the taxpayers should not be penalized for paying the total amount in 2023. The taxpayers should receive credit for the total amount of the 2023 Tax Year and not just half. Many taxpayers routinely pay their taxes in full instead of splitting payments in half. With taxpayers now breaking up the tax payments into two separate payments, it will have an unintended effect on the county's cash flow.

Therefore, we respectfully request that this be taken into consideration and taken up during the anticipated upcoming special session. The solution to resolve this entire issue is to revise the effective date of this credit, in which any timely payment for Tax Year 2023 made within 2023 is eligible for a tax credit on the 2023 tax income return filed in 2024. If taxpayers desire to pay their taxes in total in 2023, they will be eligible for a credit for the total amount in 2024. If a taxpayer chooses to pay the first half in 2023 timely, that amount will be eligible for a credit in 2024, and then the second half will be eligible the following year, respectively. This will avoid the unnecessary penalization of those who elect to pay their taxes in total in 2023 and those who elected to pay just the first half in 2023.

Again, we thank you for providing much-needed tax relief to the deserving taxpayers of Kanawha County and all West Virginians. We implore you to consider this issue and our proposed solution at the anticipated upcoming special session.
